Richard L. "Rich" Stovall, Sr., age 67, of Lakes of Four Seasons & Naples, Florida, passed away on Thursday, February 16, 2012. He was a retired pipefitter with Local 597 of Chicago, after 44 years. Rich began his career at BMW Constructors as a foreman in June of 1984. After only 3 months, he was promoted to Superintendent in Sept. 1984.
